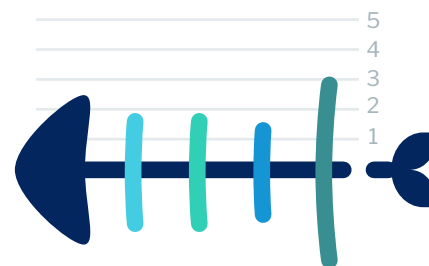

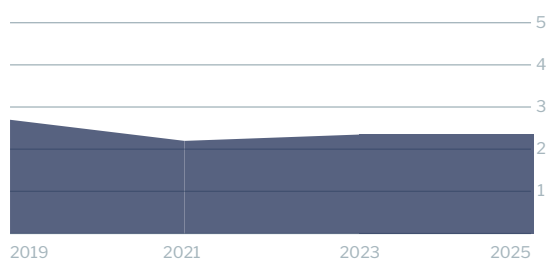

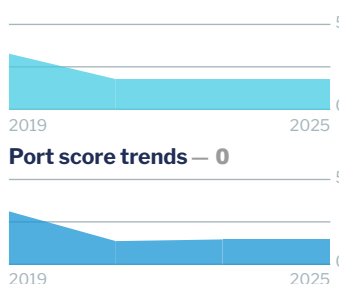

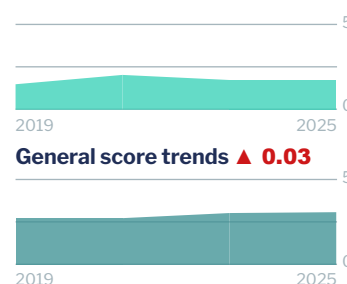

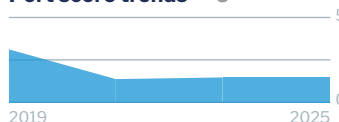
Coastal score trends — 0



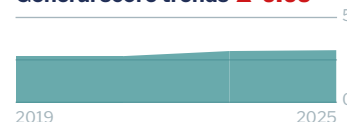
Flag score trends ▼ -0.01
