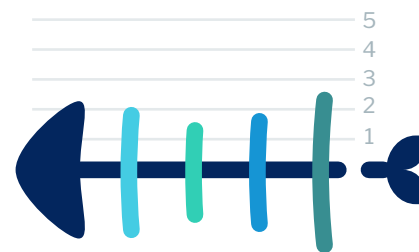

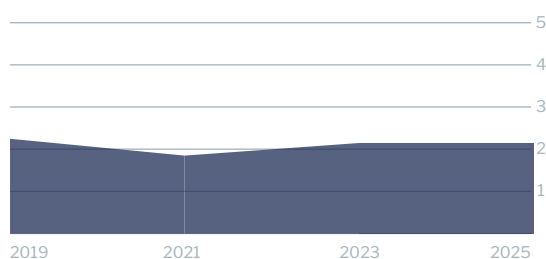

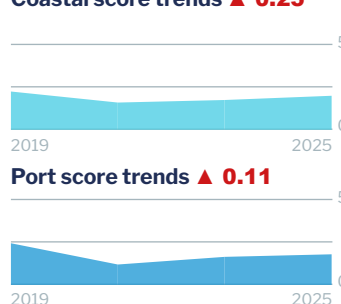

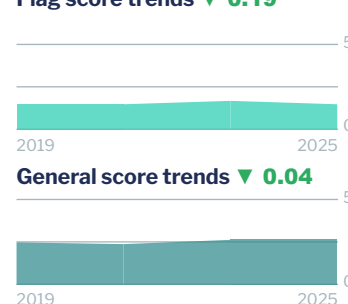

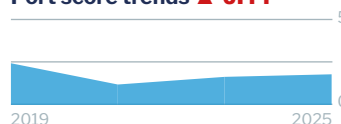
Coastal score trends ▲ 0.25



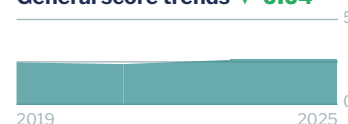
Flag score trends ▼ 0.19
